### NOTICE TO PARTICIPANTS: SUMMARY OF MATERIAL MODIFICATIONS

You are a participant in the Medical Expense Reimbursement Plan ("Plan") of the California Firefighters Benefit Trust ("Trust"). This Summary of Material Modifications contains important information about your rights and benefits under the Plan. Please file it with your important documents. The following are highlights of Plan Amendment No. 12. In addition, you may also receive a copy of the full Plan Amendment upon request by contacting the Trust Office at (844) 353-7839.

## I. TRUST NAME CHANGE

Due to expansion of participation in the Trust to firefighter Locals throughout the state of California, the Board of Trustees recommended a Trust name change to the Boards of Directors of the three governing Associations. The Boards of Directors of Fallbrook Firefighters Association Local 1622, Riverside City Firefighters Local 1067, and San Diego City fire Fighters Local 145 voted to change the name of the Trust from Southern California Firefighters Benefit Trust to California Firefighters Benefit Trust. Please make a note of this change, as you will start to see a new logo and header on documents related to your medical expense reimbursement benefits.

## II. PLAN BENEFIT INCREASE

1) <u>Benefit Increase through Adjustment of "Unit Multiplier</u>." The Board of Trustees recently approved an increase in the Unit Multiplier for claims received on or after March 1, 2022. An increase in the Unit Multiplier results in a benefit increase for all Regular Beneficiaries.

On October 19, 2021, the Board of Trustees met with a professional actuary to study the Trust's financial health and projected earnings. As a result of Notice to Participants: Name Change and Benefit Increase California Firefighters Benefit Trust Page 2

their discussions with the actuary and review of his report, the Board of Trustees decided to *raise the Unit Multiplier of the Plan (used to calculate monthly benefit levels) from \$0.23 to \$0.29* for all claims received by the Trust Office on or after March 1, 2022.

The Board of Trustees hopes to be able to raise the Unit Multiplier again in the future, but the Trustees cannot promise to do so. The Trustees reserve the right to increase or decrease the Unit Multiplier for current and/or future retirees at any time.

2) <u>Conversion of Lump Sum Transfers into Active Services Units</u>. The Plan provides for optional conversion of your lump sum transfers (e.g., leave transfers and Option C transfers) into additional Active Service Units. You may elect a conversion in order to attain eligibility for a monthly benefit, or to increase your monthly benefit level after retirement. As a result of the increase in the Unit Multiplier (UM), the Trust Actuary developed a new Contribution Conversion Table. *The new Table will be effective for Conversion Election Forms received by the Trust Office on or after March 1, 2022.* A copy of the new Table, which is Appendix B4 to the Plan, is posted on the Trust website for your reference.
