## MEDICAL EXPENSE REIMBURSEMENT PLAN OF THE SOUTHERN CALIFORNIA FIREFIGHTERS BENEFIT TRUST

## SUMMARY ANNUAL REPORT

This is a summary of the annual report for the Medical Expense Reimbursement Plan of the Southern California Firefighters Benefit Trust (Employer Identification No. 33-0581737, Plan No. 501) for the year ended February 28, 2015. The annual report has been filed with the Department of Labor's Employee Benefits Security Administration as required under the Employee Retirement Income Security Act of 1974 (ERISA).

Health, dental, and vision insurance premiums, long term care insurance premium, and qualified medical expenses reimbursement benefits for retired participants, as defined by the Plan document and the Trust agreement, are provided by contractual contributions from the participants and the participating employers.

## BASIC FINANCIAL STATEMENTS

The net assets of the Plan, after subtracting liabilities, totaled \$19,021,058 at the end of the year compared to \$13,218,572 at the beginning of the year. During the period, the Plan experienced an increase in net assets of \$5,533,717. This change includes unrealized appreciation or depreciation in the value of plan assets; that is, the difference between the value of assets at the end of year and the value of assets at the beginning of the year or the cost of assets acquired during the year.

The Plan's gross income was \$6,346,683 of which contributions from employers were \$1,923,170, contributions from participants were \$1,624,879, contribution from association were \$64,345, transfer of assets from Northern California Firefighters Retiree Medical Trust \$1,710,180, joinder fees from Chico Firefighters was \$4,300, and investment income was \$1,019,809. The Plan expenses were \$544,197. These expenses included \$381,843 of benefits paid to participants and beneficiaries, \$15,054 of investment advisors fees, and \$147,300 of administrative expenses.
